## **Standing Committee on Budget Equity and Transparency**

## **Starwood Advisory Group**

The Land Reutilization Authority (LRA) receives title to all tax-delinquent properties not sold at the Sheriff's sale. It also receives titles to properties through donations. The SLDC <u>Real Estate Department</u> maintains, markets, and sells these <u>properties</u> and performs land assemblage for future development.
